# **Article 1: Denomination**

It is hereby created this day 10 September 2006 a not-for-profit making organization (association) known as **Promotion of Sustainable Development in Donga Mantung** abbreviated PROSDOMA

# **Article 12: Loss of Membership**

# **Article 13: Management Organs**

In order to be effective in its orientation PROSDOMA has two management organs. These management organs take major decisions affecting the associative

## Article 14: General Assembly

The General Assembly of Members is the supreme organ of PROSDOMA. It meets twice a year during ordinary sessions. The General assembly can be called up for an extraordinary session to adopt or review pertinent issues affecting the life of the union. It is chaired by the Founding President and the AGM could be summoned by the Chief Executive Officer or 2/3 of members of the General Assembly. The Founding President is assisted during the General Assembly by the Chief Executive Officer.

#### Article 15: The Coordination Unit

The coordination unit is in charge of overseeing the day- to- day running of the association. It meets on monthly basis to evaluate and assess the level of implementation of tasks assigned to it by the general assembly to its specialized organs. It is made up of the Chief Executive Officer, Project Manager, Financial Secretary, Chief Whip, Treasurer and 02 Advisers and members of the specialized organs. These specialized organs are:

- Animation Committee abbreviated AC (3 members)
- The Commercialization Committee abbreviated CC (2 members)
- The Input Supply Committee abbreviated ISC (2 members)
- The landscape Restoration Committee abbreviated LARC (2 members)
- Processing and Transformation Committee abbreviated PROT (2 members)
- Task Force Committee to combat illegal logging abbreviated TAFCO (5 members)

#### The Chief Executive Officer

The project manager oversees all projects and plays the role secretary of the General Assembly to take minutes during meetings. He/she keeps copies of the resolutions taken by the General Assembly. He/she is also in charge of keeping all the archives of the General Assembly.

## Financial Secretary

The financial secretary keeps records of all financial transactions carried out by the association and its members. He/she presents the financial situation of the association to the General Assembly He/she works in collaboration with the cashier/treasurer.

# Treasurer/Cashier

The treasurer keeps all financial records as well as petit cash including bank transactions of the association. He/she disburses money and also withdraws and keeps money in the bank. He/she is signatory into the associations' bank account.

#### **Advisers**

They play an advisory role in the association which is also very pertinent for the sustainability of the life of the union. Some members could be co-opted as advisers. The advisers are assisted in their advisory roles by a consultant.

# Chief Whip

The Chief Whip is the disciplinary master. He oversees and ensures that the IRR are respected by all members.

#### 19-Term of Office

The executive term of office shall be five years renewable once whereas the term of office of an elective post, elected to fill a vacancy shall be the remaining term of office of his predecessor or other incumbents. ## 20- Report and Statement of Accounts

A statement of accounts of the association shall be prepared by the Chief Executive Officer, Treasurer and the Financial Secretary before the year ends. The Chief Executive Officer shall present the activities report and statement of accounts to the assembly

#### 21: Amendment

For any amendment to be effective, atleast 2/3 of members most have voted in favour. A copy of the amended section should be submitted to the office or the Senior Divisional Officer for Donga Mantung Division within 7 days for notification and information.

#### Article 23: Bank Account

The association shall open a bank account in any financial institution of its choice to carry out its transactions. Signatories to the account shall be the Chief Executive Officer and Financial Secretary and Treasurer

#### **Article 24: Dissolution**

PROSDOMA could be dissolved if it has achieved its goal or because of bankruptcy. In case of voluntary dissolution, the assets of the association shall be handed to any other community association with similar objectives in Donga Mantung Division.

# **Article 25: Bankruptcy**

In case of bankruptcy, and where the association finds it difficult to function normally, a liquidator shall be appointed to negotiate with creditors and debtors. This liquidator shall be appointed following the procedure laid down by the regulations in force.
